Jpay update- Today Feb. 28th 2018. Mailroom brought me directly Jpays printed from Feb. 2nd-Feb 7th. See I expressed not originally getting them. Then spoke to mailclerk that has been here as long as myself. Never known her to be dishonest! I asked her to please get me jpays from specific dates. I seen her again days later as she passed out legal mail. Asking if she forgot. She said no & named two others on pod she printed for them missing jpays. That she printed mine also. So not only did I fail to get the original printing, which not sure if was done or ~~not~~. I do not know. I did not get the copies! Finally they brought them to me directly. However I did not have notes readily available, so the only dates off top of head to mention was Feb. 2-6th.

They told me was none on Feb 4th or 6th.

I received 6 that was missing. If due to previous posting you filed complaint on these specific jpays. Please! for sake of clarity & honesty. Please send another email to Ombudsman tdcj.gov/ombudsman & inform them I finally got them.

They are as follows. Initials of sender & date.

Feb. 2nd- A.T , N.S.DA, (I would have never known ~~sent~~)

Feb. 3rd- M.d.G & M.W.B

Feb. 5th. No, I didnt get yours Angela. :)

From later dates.

Feb. 19th- Nothing. Feb. 21st -nothing.

Feb. 22nd- M.A

Feb. 23rd- Nothing

Feb. 24th- J.G , M.P

Feb. 25th- J.D.B #9

Feb. 26th- M.W.B-(Please tell parents I said Thank you!)

They started a new thing, where we have to sign for jpays now. Though it only lists -Date of signing, officer name that sorted mail, officer initial that passed out jpay, & number of jpays given. Then our name, #, & we initial it.

Which can be good & bad. Good because if ever an officer did do anything with mail. Helts that! (I dont have officer conflicts.) Also it reduces likely-hood of officer giving to wrong person here. As they have to sign & #, & we sign.

So for those reasons it is great.

The bad I see, is that if for example duplicates are accidentally printed & some are not. The log could show 4 jpays that day. Again log does not reflect actual dates on jpays. Only day that it is given to us. So if from Friday-monday I get 10 actual sent to me. On monday I sign for 8 that are given.

If I don't know missing jpays & such. They can say "well you signed for 8 on monday!"

Someone ended up with copies of ones they had already received. Which means someone somewhere made error.

Me expressed was missing some from dates that should have been delivered on tuesday. Though ended up signing for some that was copies.

Bottom line, it ends the potential errors on officers end.

To the most that can reasonably be done.

So now if problems continue. That means it can ONLY be at the beginning of the line.

So shall see how it goes.

Again if any complained about Feb.2-5. Please inform that it has been resolved for those dates. The others I still don't know.

Ya know, the wild part is. I knew I had one from that area of the month from Meike. Also expected one from Amy as didn't get visit. I just knew I got none from 2-6th so said I was missing them. I ended up getting 6 that was missing! One was person that was new, so would not have expected from her & might have never known if she thought I just ignored it.
